Temple/Tomb Presentation — Tuesday, May 13, 2008, 6:45 p.m.

I will give a combined Temple/Tomb presentation lasting 1½ hours. The address is 7635 W. North Avenue (on the corner of Wauwatosa Avenue [76th Street] and North Avenue). There is plenty of parking and the location of the Wauwatosa Library is easy to reach from Milwaukee and the surrounding area.

The event is free, of course. Everyone is welcome. I cover a great mass of historical material in a surprisingly short time (short for me) and audiences are usually overwhelmed.

Wauwatosa (a western suburb of Milwaukee, Wisconsin) is home territory for me and so is that library. I grew up within 6 blocks of that library and spent many happy hours there as a teenager.

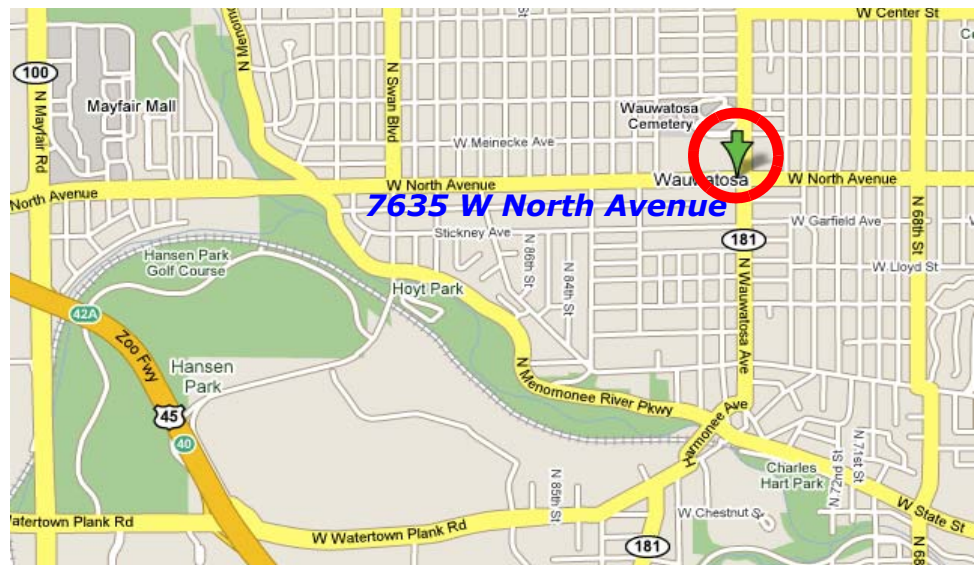
I look forward to seeing some old friends from school. Some relatives may show up.

David's Tomb Presentation — June 2008 — Portland, OR

Date and time scheduling details are being worked out for me to deliver Part 2 of an expanded Temple/Tomb lecture series. This second part will take place some time in early June, in the eastern portion of Portland, Oregon.



This lecture a visual slide presentation showing the evidence for the location and future discovery of King David's Tomb. The bodies of King David and others are in the tomb structure, in the City of David, along with (hopefully) many important objects and written documents inside the 5 to 7 chambers of the tomb structure.

In the time of the apostle Peter it was public knowledge where King David was buried. It was also public knowledge that his sepulchre was intact, and that David's body was in the Tomb:

"Men and brethren, let me freely speak unto you of the patriarch David, that he is both dead and buried, and his sepulchre is with us unto this day. ... For David is not ascended into the heavens."

• **Acts 2:29, 34**

In this lecture I go into detail (greater than in a combined Temple/Tomb lecture) to demonstrate clearly the location and future discovery of the Tombs of the Jewish Kings David and Solomon. Biblical evidence shows that these Tombs are in close proximity to the correct Temple location demonstrated by Dr. Martin's Temple research that ALL the Temples of Israel were located above and west of the Gihon Springs. Only with that vital information can the Tombs at Jerusalem be located.¹

Such unopened Tombs would yield information far more important than any ancient tomb, much more than the Tomb of King Tutankhamen. The value to the world of would make the Dead Sea Scrolls pale into relative unimportance.

This presentation will be at a local Portland congregation of the Church of God (Seventh Day). I will notify you all in the Portland area to attend, particularly if you have not seen this presentation before.
